

# 2023 District Council (DC) Ordinary Election

The 2023 DC Ordinary Election will be held on 10 December. It holds great significance for being the first large-scale territory-wide election following improvements to the district governance



system and reforms to the DCs. The new DCs will focus their efforts on livelihood issues and perform their district services and advisory functions, fully implementing the principle of "patriots administering Hong Kong and contributing to the good

governance and long-term stability of the HKSAR. All eligible electors are invited to cast their votes on that day.

Ms Bernadette LINN, the Secretary for Development, and the heads of the nine departments under the jurisdiction of the Development Bureau, including Ms Joyce TAM, the Land Registrar, took a short video appealing to the public to vote in the DC election. The video has been posted at the Land Registry website.





#### Financial Secretary, Permanent Secretary for the Civil Service and the Land Registrar Promoted Voting to the Land Registry Staff

**M**r Clement LEUNG, the Permanent Secretary for the Civil Service, together with representatives of civil service groups, as well as Mr Paul CHAN, the Financial Secretary, visited the Land Registry offices in the Queensway Government Offices on 29 November and 8 December respectively to promote the election to our staff members and encourage them to cast their votes with their families and friends.



**T**o further promote the voting message in the department, the Land Registrar and Mr K. F. PANG, the Registry Manager visited our staff members stationed in Kowloon Bay and Sha Tin on 30 November and 4 December respectively appealing them to shoulder their civic responsibility by casting their votes on the polling day.

**Title Registration** 



We continue to actively prepare the implementation of the title registration system on newly granted land first ("new land first" proposal).

We are working closely with the Department of Justice to prepare the legislative amendments to

the Land Titles Ordinance (Cap. 585). Other preparatory work, including development of a new computer system, is also underway. We will continue to engage key stakeholders to work out the implementation details and aim to introduce the legislative amendments into the Legislative Council within 2024.

### **Events and Activities**

#### Visit by Real Estate Registry of Saudi Arabia

A delegation led by the Chief Executive Officer of the Real Estate Registry of Saudi Arabia visited us on 7 September 2023. We briefed them on the roles and functions of the Land Registry and had a useful exchange with them on land registration matters. The visit provided good opportunities for sharing experience and insight on continuous improvement to land registration services and the future title registration systems in Saudi Arabia and Hong Kong.










#### Visit to Shenzhen Real Estate Registration Center

A delegation led by the Land Registrar paid a visit to the Shenzhen Real Estate Registration Center (the "Center") on 28 September 2023 to deepen our understanding of the operation of the Center and the land registration services provided. Apart from a guided tour to the Center, the delegation also exchanged experience and views with the senior officials of the Planning and Natural Resources Bureau of Shenzhen Municipality and the Center over the latest developments of land registration regime in Shenzhen and Hong Kong. The visit provided useful perspectives to the title registration system to be introduced in Hong Kong.









#### **Registrars of Title Conference 2023**

To keep abreast of the latest trends and developments in land registration, the Land Registry maintains close ties with its overseas counterparts. From 10 to 13 October 2023, the Land Registrar led a delegation to attend the Registrars of Titles Conference 2023 in Melbourne, Australia. The theme of this year's Conference was "Future of Land Registration in a Post Pandemic Digital World". The Conference brought together Registrars and their delegates from various overseas jurisdictions and provided an invaluable opportunity for all participants to exchange insights and experience of the latest developments in title registration and registry business.




# Launch of Guangdong and Hong Kong "Cross-boundary Public Services"

Guangdong and Hong Kong "Cross-boundary Public Services" (CBPS) was launched on 2 November 2023 with a thematic website to facilitate enterprises and members of the public in Hong Kong and Guangdong Province and Municipalities to access government services online in both places anytime without the need for crossboundary travel in person.



**S**ix Land Registry's services including IRIS Online Services and Property Alert are placed on the first batch of 54 CBPS for use by Mainland residents or Hong Kong residents living in Guangdong. They are now able to enjoy user-friendly and convenient cross-boundary search services. This will facilitate greater economic cooperation between Hong Kong and the Guangdong-Hong Kong-Macao Greater Bay



#### Land Registry Trading Fund (LRTF) Annual Report 2022/23

The year of 2022/23 presented both opportunities and challenges to the Land Registry. Given the challenging business environment, we have been exercising prudent and cost-conscious measures while striving to maintain quality delivery of services.

The LRTF Annual Report 2022/23 gives an account of various activities and business performance of the Land Registry in the past year. The report with the audited financial statements by the Director of Audit was released and tabled in the Legislative Council on 25 October 2023.



### **Corporate Citizenship & Achievements**

#### **Students Internship Schemes**

As a caring organisation which promotes equal opportunities for employees and eliminates discrimination in the workplace, we participated in the 2023 Internship Scheme for Students with Disabilities organised by the Civil Service Bureau. We also offered internship placements under the Post-Secondary Student Summer Internship Programme 2023 and Internship Programme for Non-ethnic Chinese Students 2023, both aiming at helping students to gain work experience.

A total of eight undergraduates joined us in various Divisions during their internship from June to August 2023. They were arranged to work in an office setting and tasked with a diverse range of tasks to broaden their horizon and enhance their understanding of the operation of the registry. The internship placement affirmed all students with invaluable and practical work experience that fosters confidence and preparedness for a promising career outlook.



#### Business-School Partnership Programme



We participated in the Business-School Partnership Programme launched by the Education Bureau. The Programme aims at promoting better co-operation and closer alliances between the business sector and schools and providing students with opportunities to gain wider perspective of the world and get prepared for life in society.

On 6 July 2023, a half-day workplace visit was organised for students from Salem-Immanuel Lutheran College under the Programme. Apart from visit to various operational sections of the Land Registry, they also participated in career talk and sharing session to learn more about the operation of the department. The students expressed that the visit was useful and helped them plan their future study and career.

Preparation of Meal Boxes for People in Need of Food Assistance
